We hereby inform you about the REQUISITES TO BE GRANTED A FILM AND/OR PHOTOGRAPHIC PERMIT inside the Protected Natural Areas of the Province of Chubut; stipulated by Resolution N° 160-STyAP-14, which is at your disposal.

- Written request for the permit, stating the number of days, exact dates, methodology, purpose and destination of the film and/or photography work, details of the crew members, Full Name and Passport Number, amount and functions held by each-, and whether the crew will remain together or split to work in different areas. Personal and Professional background -Curriculum Vitae signed- and Personal Accident Insurance for each member of the crew.
- Payment of a fee amounting to THIRTEEN THOUSAND FIVE HUNDRED ARGENTINIAN PESOS (\$13.500) per day in concept of film permit
- Payment of a fee amounting to NINE THOUSAND ARGENTINIAN PESOS (\$ 9.000) per day per person in concept of photography permit.
- The Film and/or photography crew who has been granted a permit for five (5) days or more, will receive, since the sixth day a thirty percent (30%) discount on the daily fees mentioned above.
- Composition of the Film and/or Photography crews:
  The fees established in the previous point will be applicable to each one of the permit holders according to the information submitted in the Plan of Work.
- Payment of ARGENTINIAN PESOS EIGHT HUNDRED (\$800) per day to the Official Overseer assigned by the Tourism authorities, as well as the daily expenses for the overseer's food and accommodation. The overseer will accompany the film and/or photography crew until the work is completed, in order to make sure that the Legislation concerning the conservation and protection of the local resources is fully observed.
- Payment is due in cash 48 hours previous to the beginning of the film/photo work, either in cash at the premises of the Ministry for Tourism and Protected Areas of the Province of Chubut in Rawson, or by way of a bank transfer to the following bank account:

- The permit holder will take over all transfer expenses, and he will fax the bank receipt (both sides) to the Ministry for Tourism and Protected Areas of the Province of Chubut.
- Underwater film and/or photography of wildlife (whales, sea lions, dolphins) is permitted only on condition that there is no human interaction with the animals. No more than two (2) people (1 cameraman and one assistant diver) are allowed to get into the water simultaneously.
- Provided the filming and/or photography carried out from a boat, this boat must be authorized by Argentine Naval authorities (Prefectura Naval Argentina) and must be steered by licensed trained staff (guía ballenero).
- For camouflage reasons the use of dark clothing is indicated.
- After completion of the work, and within One Hundred and Eighty (180) Days, the permit holder will give the Ministry for Tourism and Protected Areas of the Province of Chubut the following material:

## Film:

A minimum of three minutes of footage per day of granted permit, all included in one (1) copy with the same format of the original.

## Photography:

One original per day of granted permit, in digital format with a minimum of 600 DPI, 20 cm horizontal base in TIFF, RAW o NEF.

This material may only be used or reproduced in institutional marketing, mentioning the author and/or the film or photography group.
